**INSTALLATION PAYMENT (IF APPLICABLE)**

**FIRST PAYMENT**

**NB: Please note that a debit order for the monthly service fee is mandatory for residential subscribers. It is mandatory for all commercial subscriber to sign the debit order form, unless arranged otherwise in writing.**

The first invoice by FibreWireless will include your installation fee and your pro-rata subscription for the month the installation took place.

Depending on the day of installation you will receive your second full invoice for the month in advance, which will go off on debit order.

All additional invoice & outstanding balances will be debited including you subscription.
